

# **Immigration Tourism Update**

September 2025

### **Overview**

- Immigration is crucial to the Government's economic growth agenda and Immigration New Zealand (INZ) is committed to ensuring that visa processing is not a barrier to New Zealand getting the migrants we need to grow.
- INZ aims to provide a trusted and effective immigration service and is committed to processing all visa applications as quickly as possible.
- Visitor visa processing remained positive for the 2024/25 financial year:
  - Most of New Zealand's visitors do not need a visa to come here and instead can travel on a New Zealand electronic Travel Authority (NZeTA), of which more than 1.6 million were approved.
  - o INZ also approved over 443,000 visitor visas.
  - o Combined, more than 1.6 million people visited New Zealand in this period.
- Comparatively, from 01 January to 31 August 2025:
  - Over 888,000 NZeTAs were approved.
  - INZ also approved almost 274,000 visitor visas.
  - o Combined, over 1 million people visited New Zealand in this period.
- Processing times continue to improve, the average visitor visa processing time in the 2024/2025 financial year was 7 working days. These times are improving- the average from 01 January to 31 August 2025 was 5 working days.

#### China

- China is a very important market for New Zealand, providing opportunities for our tourism sector and connecting friends and family.
- INZ carefully monitors application flows and trends to ensure the right resources are in place to meet demand from this important market.
- New Zealand visitor visa offerings for Chinese nationals are more generous than other groups of travellers, reflecting the importance of the relationship with China. Most Chinese visitors receive a five-year multiple entry visitor visa, making it easier for Chinese visitors to return to New Zealand.
- For the 2024/2025 financial year, we received over 236,000 visitor visas.
- Processing times went from 7 working days for the 2023/24 financial year, to 6 working days in the 2024/2025 financial year. These times are improving - from 01 January to 31 August 2025 the average processing time is 5 working days.
- In May, the Head of INZ and Deputy Chief Operating Officer visited China to promote local engagement and meet with key stakeholders, namely in the education and tourism sectors.
- The visit provided valuable insights into the Chinese market, particularly around visa processing expectations and the importance of streamlined, accessible information.
- In June, the Associate Deputy Secretary joined the Prime Minister's official delegation to China, reinforcing the significance of the market and its technology-driven nature.



- These trips solidified that the Chinese market responds strongly to clear branding and expect fast, reliable communication. While language is less of a barrier due to widespread use of translation tools, the demand for timely and accurate content remains high.
- The Government recently announced changes to make it easier for Chinese tourists to travel to New Zealand as part of their plan to drive economic growth and increase the number of Chinese tourists.
- From November 2025, Chinese visitors who hold a valid Australian visitor, work, student or family
  visa travelling to New Zealand from Australia will be able to come to New Zealand for up to 3
  months using only a New Zealand Electronic Travel Authority (NZeTA) rather than applying for a
  visa, as part of a trial for 12 months.
- From late October 2025, Chinese nationals will also be able to transit through New Zealand on a Transit NZeTA, without having to apply for a separate transit visa. More detail about these changes will be available and communicated mid-September.
- INZ now has more support in place to help make it easier for Chinese tourists applying for a visa. This includes
  - o additional contact points for the Chinese travel industry with staff based in China to support Approved Destination Status (ADS) agents, including a phone number they can call for direct support; and
  - o web content in Simplified Chinese: <u>Visitor Visa application guide for citizens of China</u>: <u>Immigration New Zealand.</u>

### India

- India is a very important market for New Zealand and is the second largest source of visa required visitors to New Zealand.
- From 1 December 2025, Immigration New Zealand will only accept police clearance certificates issued by a Regional Passport Office of the Indian Minister of External Affairs when required from Indian national visa applicants living in India.
- This will ensure that the police clearance certificates we receive are more consistent and is in line with the requirements of other countries.
- In 2024, INZ decided around 85,000 visitor visa applications from Indian nationals, which accounted for 16% of the total number of visitor visa applications submitted that year.
- For the 2024/2025 financial year, we had over 77,000 Indian visitor arrivals and decided over 80,000 visitor visa applications from Indian nationals. Comparatively, from 01 January to 31 August 2025 we had over 45,000 Indian visitor arrivals and approved over 39,000 visitor visa applications from Indian nationals.
- In March, the Head of INZ travelled to India and gained some valuable insights about the travel movements of Indian nationals, including that there are a growing number of people with disposable income, who in turn are favouring shorter and more frequent trips to a variety of destinations. This means Indian nationals are booking more travel at short notice and what they want from INZ is certainty about being able to travel on chosen dates.
- In July, Tourism New Zealand (TNZ) hosted Kiwi Link India 2025, an offshore event designed to build connections between representatives of New Zealand's tourism industry and key travel industry professionals across India.
- Representatives from INZ participated in the event which took place in Goa and Delhi, with
  the aim of informing the Indian tourism sector about New Zealand's immigration system
  requirements. INZ was commended for its efficient processing times, receiving positive
  feedback overall.
- Participating in Kiwi Link, and the positive feedback, reflects the shared commitment between MBIE, INZ, and Tourism New Zealand to deliver great service and build strong, lasting relationships to help grow our tourism industry.
- Last year, after attending Kiwi Link in 2024, we put in place a range of initiatives to improve
  the timeliness of visitor visa process, including a new approach to processing visitor visa
  applications from large family groups to ensure a consistent experience for all family
  members.
- These initiatives have contributed to a reduction in processing times for Indian nationals
  from an average of 10 working days for the 2023/24 financial year, to 9 working days in the
  2024/2025 financial year. Processing times continue to improve from 01 January to 31
  August 2025 the average processing time is 6 working days.



- INZ has also been working hard to inform the Indian market on visa requirements which has
  led to a significant improvement in the quality of the applications that INZ receives. For the
  2024/2025 financial year approval rates for Indian visitor visas were at 80% and remain
  sitting at 80% from 01 January to 31 August 2025.
- To reflect the importance of the Indian market and ensure we are well connected, INZ has
  established a dedicated position in our New Delhi office to work directly with and provide
  support to travel agents in the market.
